
We hereby apply for a Club License for season 2016.

It is hereby certified that the club has complied and will continue to comply with the criteria referred to in the National Club Licensing Regulation and NFF Club Licensing Regulations and we confirm undertaking the following:

- A. To recognize, as legally binding, "the statutes, rules, regulations and decisions" of FIFA, NFF, (NFF member Association), and if applicable the national league;
- B. To recognize the exclusive jurisdiction of the court of Arbitration for sport (CAS) for any dispute of international dimension, and in particular involving FIFA and/or NFF;
- C. To recognize the prohibition to ordinary courts under the statutes of FIFA and NFF;
- D. At National level, to play in competitions that are recognized and endorsed by the (NFF member Association);
- E. At Continental level, to play in Competitions that are recognized by NFF. (For the avoidance of doubt, this provision does not relate to friendly matches);
- F. To abide by and observe the provision and conditions of the National Regulations;
- G. To ensure that all submitted documents are complete and correct;
- H. To authorize the Club Licensing Authority to examine documents and seek information, and also in the event of any Appeal procedure to seek information from any public Authority or private Body according to National law;

- I. That CAF and/or NFF reserve the right to execute post checks at National level, reviewing the assessment procedures and decision-making in case FIB fails to implement it.
- J. That all our players are registered with the (NFF Member Association).
- K. That all our Professional players have written employment contracts with the registered body, according to articles 2 and 5 of the FIFA regulations, for the statutes and Transfer of players;
- L. That we are fully responsible for the football team composed of registered players, participating in national and international competition;
- M. That the (NFF Member Association) is provided with all the necessary information and/or documents relevant to proving that the licensing obligations are fulfilled, as these obligations relate to the sporting, infrastructure, personnel and Administrative, Legal and financial Criteria set out respectively under relevant Articles of the NFF Club Licensing Regulations;
- N. That all compensation paid to players arising from contractual or legal obligation and all revenue arising from gate receipts are accounted for in the books of the registered member;
- O. That the (NFF) is provided with information on the reporting entity/entities in respect of which information about the sporting, infrastructure, personnel and Administrative, Legal and Financial Criteria are required to be provided. In turn, the (NFF Member Association) must assess whether, in respect to this, the selected reporting entity/entities is /are appropriate for the Club Licensing System;
- P. That the rights and duties of our staff are defined in writing;
- Q. That any event occurring after the submission of the licensing documentation to the (NFF) representing a significant change compared to the information previously submitted, will be notified to the NFF by the set deadline.
